# **BANYAN GOLD CORP.**

## MANAGEMENT'S DISCUSSION AND ANALYSIS FOR THE NINE MONTHS ENDED JUNE 30, 2013

#### Background

This discussion and analysis of financial position and results of operations is prepared as at August 26, 2013 and should be read in conjunction with the unaudited interim financial statements and the accompanying notes for the nine months ended June 30, 2013 and the audited financials for the period ended September 30, 2012 for Banyan Gold Corp. (the "Company"). Except as otherwise disclosed, all dollar figures included therein and in the following management discussion and analysis ("MD&A") are quoted in Canadian dollars.

#### **Company Overview**

The Company was incorporated by a Certificate of Incorporation issued pursuant to the provisions of the Alberta Corporations Act ("**ABCA**") on July 26, 2010 under the name Banyan Coast Capital Corp, which was subsequently changed to Banyan Gold Corp under a certificate of amendment on February 14, 2013. On November 23, 2010 the Company filed a final prospectus in the provinces of British Columbia, Alberta, Saskatchewan and Ontario to issue 2,000,000 common shares at a price of \$0.15 per share (the "**Prospectus**"). On November 24, 2010, the Company received final receipts for a prospectus and became a reporting issuer in the Provinces of British Columbia, Alberta, Saskatchewan and Ontario.

Banyan Coast Capital Corp. successfully completed its initial public offering raising gross proceeds of \$300,000 on January 25, 2011. A total of two million common shares in the capital of the corporation were subscribed for at a price of 15 cents per share.

Banyan commenced trading on January 27, 2011 on the TSX Venture Exchange and trades under the symbol BYN.

On August 31, 2012, the Company entered into a Letter of Intent (the "LOI") with Argus Metals Corp. ("Argus") to acquire a 100% interest in Hyland Gold Property (the "Hyland Property") in the Watson Lake Mining District of the south eastern Yukon Territory, Canada.

On October 4, 2012, the LOI with Argus was upgraded to a Definite Assignment and Transfer Agreement ("Definite Agreement"). On February 15, 2013, the definite agreement was completed with the issuance of 4,000,000 Banyan shares to Argus in conjunction with a non brokered private placement of 5,000,000 Units at \$0.10 per unit to complete the Company's qualifying Transaction under the rules of the TSX Venture Exchange. On March 1<sup>st</sup>, 2013 the Company completed a non brokered private placement of 2,000,000 Units at \$0.10 per unit.

## **Results of Operations**

#### Three months ended June 30, 2013

During the three month period ended June 30, 2013, the Company recorded a net loss of \$(65,934) vs a loss \$(5,192) in quarter ended June 30, 2012. The current period loss is related to management fees of \$42,000 (Nil June 30, 2012), Professional Fees of \$10,500 (Nil June 30 2012), Travel of \$6,652 (\$764 June 30, 2012) and Transfer Agent Fees \$3,189 (Nil June 30, 2012). These variances relate to the Company transferring from a Capital Pool Company to a going concern.

At the Annual General Meeting of Shareholders on June 10, 2013 the shareholders re-elected Richmond Graham and Mark Ayranto as directors and elected Jay Collins, Tara Christie and Gregory Melchior as new members of the board of directors.

Mr. Collins is President of Merit Consults International Inc., a highly regarded project and construction management company in the mining industry. Ms. Christie is President of Gimlex Gold Mines Ltd., one of Yukon's largest gold mining operations. Mr. Melchior, well known in the financial sector, is an investment advisor and is the Executive in Residence at the DeGroote Business School.

All resolutions put forth at the shareholders meeting were passed unanimously by shareholders.

## **Financial Condition & Liquidity**

Cash and cash equivalents at June 30, 2013 totaled \$582,924 compared to \$218,222 on June 30, 2012

The accompanying interim financial statements are presented on a going concern basis, which assumes the Company will continue to realize its assets and discharge its liabilities in the normal course of operations.

The Company does not generate cash flows from operations and has therefore relied principally on the issuance of equity securities to finance its operation activities to the extent that such instruments are issuable under terms acceptable to the Company.

If future financing is unavailable, the Company may not be able to meet its ongoing obligations, in

which case the realizable values of its assets may decline materially from current estimates. The financial statements do not include any adjustments to the amounts and classification of assets and liabilities that might be necessary should the Company be unable to continue operations.

## **Capital Resources**

The Company's capital consists of an unlimited number of Class A & B common shares and an unlimited number of Preference shares.

As at June 30, 2013, the Company had 14,334,000 common shares issued and outstanding (June 30, 2012 – 3,334,000), 333,400 stock options exercisable at \$0.15 and expiring on January 25, 2021 (June 30, 2012 – 334,400) and 3,500,000 warrants exercisable at \$0.15. (June 30, 2012 200,000 broker warrants).

During the quarter ended June 30, 2013 no stock options were granted or exercised (Nil June 30, 2012) and 3,500,000 warrants exercisable at \$0.15 were issued (Nil June 30, 2012).

## **Off-Balance Sheet Arrangements**

The Company has no off-balance sheet arrangements.

## **Proposed Transactions**

There are currently no proposed transactions.

## **Critical Accounting Estimates**

A detailed summary of all the Company's significant accounting policies is included in Note 3 to September 30, 2012 audited financial statements found on <u>www.sedar.com</u>. The accounting policies adopted are consistent with those of the previous financial year.

## **Changes in Accounting Polices**

There have been no changes in accounting policies since the September 30, 2012 yearend financial statements.

## **Future Accounting Policies**

The following new standards have been issued but are not yet applicable to the Company:

(i) IFRS 9 Financial instruments:

As part of the project to replace IAS 39, Financial Instruments: Recognition and Measurement, this standard retains but simplifies the mixed measurement model and establishes two primary measurement categories for financial assets. More specifically, the standard:

- deals with classification and measurement of financial assets;

- establishes two primary measurement categories for financial assets: amortized cost and fair value;

- prescribes that classification depends on entity's business model and the contractual cash flow characteristics of the financial asset;

- eliminates the existing categories: held to maturity, available for sale, and loans and receivables.

Certain changes were also made regarding the fair value option for financial liabilities and accounting for certain derivatives linked to unquoted equity instruments.

This standard is effective for annual periods beginning on or after January 1, 2015. The Company will adopt these standards when it becomes effective. The Company has currently not assessed the impact of adopting this standard.

(ii) IFRS 10 Consolidated Financial Statements

IFRS 10 will replace portions of IAS 27 Consolidated and Separate Financial Statements and interpretation SIC-12 Consolidation — Special Purpose Entities. IFRS 10 builds on existing principles by identifying the concept of control as the determining factor in whether an entity should be included within the consolidated financial statements. The standard provides additional guidance to assist in determining control where this is difficult to assess.

(iii) IFRS 11 Joint Arrangements

IFRS 11 applies when accounting for interests in joint arrangements where there is joint control. Joint arrangements would be classified as either joint operations or joint ventures. The structure of the joint arrangement would no longer be the most significant factor when classifying the joint arrangement as either a joint operation or a joint venture. The option to account for joint ventures (previously called jointly controlled entities) using proportionate consolidation would be removed and equity accounting would be required. Ventures would transition the accounting for joint ventures from the proportionate consolidation method to the equity method by aggregating the carrying values of the proportionately consolidated assets and liabilities into a single line item.

(iv) IFRS 12 Disclosure of Involvement with Other Entities,

IFRS 12 includes disclosure requirements about subsidiaries, joint ventures, and associates, as well as unconsolidated structured entities and replaces existing disclosure requirements.

(v) IFRS 13 Fair Value Measurement

IFRS 13 provides a single framework for measuring fair value while requiring enhanced disclosure when fair value is applied.

(vi) IAS 28 Investments in Associates and Joint Ventures

As a consequence of the issue of IFRS 10, IFRS 11 and IFRS 12, IAS 28 has been amended and will provide the accounting guidance for investments in associates and to set out the requirements for the application of the equity method when accounting for investments in associates and joint ventures.

These amendments (ii to vi) are effective for annual periods beginning on or after January 1, 2013. The Company will adopt these standards (and amended standards) when they become effective. The Company has currently not assessed the impact of adopting these standards (and amended standards).

#### **Transactions with Related Parties**

During the quarter, the Board of Directors approved executive compensation for the officers of the Company totaling \$14,000 per month.

## **Risks and Uncertainties**

The Company's financial performance is likely to be subject to the following risks:

- i) the Company has not commenced commercial operations, and has no assets other than cash, has no history of earnings and has no means to pay dividends;
- ii) until completion of the Qualifying Transaction, the Company is not permitted to carry on any business other than the identification and evaluation of potential Qualifying Transactions;
- iii) the Company has only limited funds with which to identify and evaluate potential Qualifying Transactions and there can be no assurance that the Company will be able to identify or complete a suitable Qualifying Transaction; and
- iv) In the event the Company identifies a Qualifying Transaction there can be no assurances the Company can raise sufficient financing to complete the transaction.

## **Investor Relations Activities**

The Company does not have any investor relations arrangements.

## Subsequent Event

On August 14, 2013 the Company announced that, further to the \$100,000 payment made to Victoria Gold Corp ("Victoria Gold") as outlined in our press release dated February 19, 2013, Banyan Gold has issued an aggregate of 150,000 common shares to Victoria Gold at a deemed price of \$0.05 per share as final payment pursuant to the Hyland Option Agreement (the "Option Agreement"). Under the terms of the Option Agreement, this share issuance earns Banyan Gold an undivided 100% interest in the Hyland Gold Property.
